

NOTES ON CONTRIBUTORS

Captain Christopher Bonus is an infantry officer in the Irish Army and was commissioned in 2009 to B Coy (det), 3rd Inf Bn in the Curragh. Capt Bonus worked as an instructor in the Cadet School and as a staff officer in Overseas Section, Directorate of Operations and Plans, prior to completing the 3rd LCSC in early 2022. Capt Bonus has a BA International in French and German from NUI Galway.

Commandant Stephen Mac Eoin joined the Irish Army as an Officer Cadet in 1999. He was awarded a double First in French and History from NUI, Galway (2006) and holds an MA in Archives Management from UCD (2008) and an MA in Leadership, Management and Defence Studies from Maynooth (2020). Throughout his military career Commandant Mac Eoin has been actively involved in heritage and commemoration projects within the Defence Forces, most recently serving as Officer in Charge (Director) of the Military Archives. As a member of the Government's Expert Advisory Group on Commemorations and the National Archives Advisory Council, he has led the delivery of several key archival projects informing recent historiography, including notably the digitisation of the Bureau of Military History (1913-1921) Collection and the Military Archives Oral History programme. Commandant Mac Eoin has served in a wide range of command and staff appointments. A fluent French speaker, he has completed four tours of duty overseas as a peacekeeper, in Kosovo; Chad; Lebanon and the Congo and served for one year as exchange instructor at the French St Cyr Military Academy.

Lt Cian Moran was commissioned into the Naval Service in 2018. He was awarded a PhD in International Law from NUI Galway in May 2022, and prior to that, gained a first class honours LLB in Law from NUI Galway, and an LLM in International Law from the University of Nottingham. He also holds a diploma in the Irish language from NUI Galway and graduated with a BSc in Nautical Science from Munster Technological University. He currently [Sept 2022] serves as the Navigation Officer on LÉ Samuel Beckett and served on this ship's recent operation to Lebanon. His research interests focus on humanitarian intervention as well as the law of armed conflict, the law of the sea and international law generally and he has presented at academic conferences in Europe and the Middle East.

Major Kyle Peatfield is an officer in the US Army. In 2019-20 he completed the Joint Command and Staff Course at the Irish Command and Staff School, and was awarded an MA in Leadership, Management and Defence Studies from Maynooth University.
